## All I Needed to Know About Research Administration I Learned from Judy Blume

As a child, I loved to read Judy Blume books. I fell into the world of Margaret, Peter Hatcher, Fudge, Sally J. Freidman, and a host of others. One of my favorites was (and still is) *Otherwise Knows as Sheila the Great.* Sheila is one of those characters who, on the outside, is fearless, bossy, and an expert on every subject. Internally, she is full of fears – scared of dogs, spiders, and swimming – which she masks with a bevy of excuses. She is allergic to dogs, and she has, of course, been a champion swimmer since the age of two.



At a summer arts camp, Sheila has a brilliant idea – a camp newspaper! And to

show the kids at camp that she is an expert in something, she will be in charge of everything. The camp director, counselors, and Sheila's friends are also excited about the idea and suggest she form committees to complete this big job. Her best friend Mouse is especially interested in being a reporter.

"...we can work together," Mouse said. "We can be a team."

Sheila replies "It's my idea and I'm doing everything!"

For the rest of the week, Sheila spends all her time on the newspaper's first edition titled "Newsdate by Sheila the Great." She hikes alone around the hot and dusty campground looking for story ideas. Later she is stuck inside with only the camp secretary using antiquated equipment to crank out the copies. All the while her friends are enjoying their favorite activities. <u>Together.</u>

As research administrators, we are faced with situations where it seems easier or safer to do things ourselves rather than rely on the help of others. We may think it is more efficient to complete a project and not have to explain the intricacies of the process to someone else. Some of us are self-proclaimed control freaks who experience intense anxiety at the thought of relinquishing the "boss" role. We would rather be alone, exhausted, and dusty, gripping tightly than surrender our hold. What if the project fails because we give the reigns to another person? What if our brilliant idea is a disaster because we trusted others to help, and they fell short?

## **Believe it or Not!**

Last year I had a PI who ordered an espresso machine, and she wanted to use funds from her Ro1. I asked if she could provide a justification for those items on her Ro1, thinking that she mistakenly put that as the account to be charged. She responded back with the explanation that the espresso machine was to be used for making microbial media. More specifically, her lab obtained pigeon guano from breeders, which is fairly chunky, and they boil the chunks in water, then filter the chunks using the espresso machine, and then

extract it through a sterilizing filter (which would clog immediately if they did not have the espresso machine to filter the chunks) and use that for growing the fungi to use for making microbial media.
